The fee collected by whatsoever name called either for University seats or for Management seats shall not exceed the limits specified by the APSAHPC, Vijayawada/ Dr. YSR UHS, Vijayawada from time to time.

The Management of the college shall follow the regulations made by the University/ APSAHPC, Vijayawada in making admissions, in conducting examinations and in respect of all other related matters from time to time. The Management must stringently follow the norms of the University and observe that the Physical facilities, clinical facilities, teaching and other staff are available in the college as per the Dr. YSR UHS, Vijayawada B.Sc. Paramedical Degree Statutes.

Any deviation in this regard shall lead to disaffiliation of the college without any notice.
